**INVITATION TO BID FOR THE SUPPLY AND INSTALLATION
OF 750 KVA GENERATOR SET AND
RELOCATION OF 100 KVA GENERATOR SET**

1. The *National Intelligence Coordinating Agency (NICA)*, through the *General Appropriations Act for FY 2020 (RA 11465)*, intends to apply the sum of *Eleven Million Six Hundred Fifty Three Thousand Pesos Only (P11,653,000.00)*, being the Approved Budget for the Contract (ABC), to payment under the contract for the *Supply, and Installation of 750 KVA Generator Set and Relocation of 100 KVA Generator Set*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *NICA* now invites bids for the *Supply and Installation of 750 KVA Generator Set and Relocation of 100 KVA Generator Set, with the following specifications:*

the issuance of Notice to Proceed. Bidders should have completed, within three (3) years, from the date of submission and receipt of bids, a contract that is similar to this Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instruction to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective bidders may obtain further information from *NICA* and inspect the Bidding Documents at the address given below from Monday to Friday **between 9:00 AM and 4:00 PM.**
5. A complete set of Bidding Documents may be acquired by interested Bidders from **14 October 2020 to 04 November 2020** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Twelve Thousand Pesos (P12,000.00).**
6. The *NICA Bids and Awards Committee (BAC)* will hold a Pre-Bid Conference on **22 October 2020, 10:00 AM** at the **7th Floor Conference Room, NIC Bldg., No. 5 V. Luna Road, Quezon City**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address below on or before **10:00 AM of 04 November 2020.** Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the **Instructions to Bidders (ITB)** Clause 14.
9. Bid opening shall be at **10:30 AM on 04 November 2020** at the **7th Floor Conference Room, NIC Bldg., No. 5 V. Luna Road, Quezon City.** Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.
10. All prospective bidders are reminded that the schedule for the **Opening of Bids** shall be on **04 November 2020, 10:30 AM** at the **7th Floor Conference Room, NIC Bldg., No. 5 V. Luna Road, Quezon City.** Deadline for the submission of Bids is on **04 November 2020, 10:00 AM.**
11. The *NICA* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
